**RESOLUTION NO. 2020 - 07**

**RECOMMENDING APPROVAL TO DECLARE NISSAN COMMONWEALTH, INC.  
AS THE SINGLE CALCULATED BID (SCB) FOR THE SUPPLY AND DELIVERY  
OF VARIOUS MOTOR VEHICLES WITH CONTRACT NO. VEHICLE-2020-02**

**WHEREAS**, the Laguna Lake Development Authority (LLDA) posted the Invitation to Bid (ITB) for the supply and delivery of various Motor Vehicles with Contract No. VEHICLE-2020-02 in the Philippine Government Electronic Procurement System (PhilGEPS) on October 5, 2020 and the same was posted in LLDA website and bulletin boards;

**WHEREAS**, only Nissan Commonwealth, Inc. acquired the bidding documents amounting to Php5,000.00;

**WHEREAS**, on October 14, 2020, a pre-bid conference was conducted by the Bids and Awards Committee (BAC) and was attended by three (3) prospective bidders from the following car dealers:

1. Suzuki Corporation
2. Prince Motor Corporation
3. Nissan Commonwealth, Inc.

**WHEREAS**, only Nissan Commonwealth, Inc. participated in the submission and opening of bids on October 26, 2020;

**WHEREAS**, the technical and financial component of Nissan Commonwealth, Inc. were declared "passed" after having submitted all the technical requirements and financial requirements;

**WHEREAS**, for item nos. 1 & 2, five (5) units Multi-purpose vehicle (MPV) and two (2) units Asian Utility vehicle (AUV), respectively, no bidder submitted its bid; thus, the BAC declared a failure of bidding for the two (2) items while item No. 3 – one (1) unit Pick-up truck, Nissan Commonwealth, Inc. submitted its bid price at a total of Php1,488,888.00;

**WHEREAS**, after evaluating and calculating the bid price submitted by Nissan Commonwealth, Inc., the BAC declared said bidder as the Single Calculated Bid (SCB) for item No. 3 - one (1) unit Pick-up truck;

**WHEREAS**, above premises considered, **BE IT RESOLVED**, as it is hereby **RESOLVED**:


1. To declare Nissan Commonwealth, Inc. as the Single Calculated Bid for the supply and delivery of various Motor Vehicles with Contract No. VEHICLE-2020-02.

2. To notify said bidder and require submission of latest Income and Business Tax Returns filed and paid through the BIR Electronic Filing and Payment System (eFPS) within five (5) calendar days from receipt of notice for the post-qualification.

3. To declare a failure of bidding and reposting of the Invitation to Bid for item No. 1 - five (5) units Multi-purpose vehicle (MPV) and two (2) units Asian Utility vehicle (AUV).


