**INVITATION TO BID FOR PROCUREMENT OF FIREWALL  
APPLIANCE DEVICE WITH SUBSCRIPTIONS  
CONTRACT No. FIREWALL-2022-03**

1. The Laguna Lake Development Authority (LLDA), through the **Corporate Operating Budget for 2022** intends to apply the sum of **One Million Two Hundred Thousand Pesos only (Php1,200,000.00)** being the ABC to payments under the contract for the **Procurement of Firewall Appliance Device with Subscriptions with Contract No. FIREWALL-2022-03**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The LLDA now invites bids for the above Procurement Project. Delivery of the Goods is required forty-five (45) calendar days from receipt of Notice to Proceed. Bidders should have completed, within **five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from LLDA and inspect the Bidding Documents at the address given below during office hours of 9:00AM to 3:00PM.
5. A complete set of Bidding Documents may be acquired by interested Bidders from **9:00 AM to 3:00 PM, April 12, 2022 to May 3, 2022 and until 1:30 PM of May 4, 2022** from the given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (php5,000.00)**.
6. The LLDA will hold a Pre-Bid Conference on **April 22, 2022, 1:30 PM at LLDA Library Conference Room, 3<sup>rd</sup> Floor, National Ecology Center, East Avenue, Diliman, Quezon City** through face to face meeting which shall be open to prospective bidders.
