**RESOLUTION DECLARING CANCELLATION OF BIDDING FOR THE SUPPLY OF
LABOR, MATERIALS AND EQUIPMENT FOR THE DREDGING OF SAN CRISTOBAL
RIVER MOUTH AND ACCESS TO CARDONA FERRY TERMINAL WITH CONTRACT NO.
DREDGING-2021-17**

WHEREAS, per approved BAC Resolution No. 2021-53, Harbor Star Shipping Services Inc. was declared as the Single Calculated Bid for the Supply of Labor, Materials and Equipment for the Dredging of San Cristobal River Mouth and Access to Cardona Ferry Terminal;

WHEREAS, the project is part of the budget under the General Appropriations Act (GAA) of FY 2020 allocated for different projects and scientific studies for Laguna Lake amounting to Php150 Million wherein Php50 Million was allocated for the above project;

WHEREAS, the appropriations under the FY 2020 GAA shall be available for release, obligation and disbursement not later than December 31, 2021 in accordance with Republic Act (RA) No. 11520;

WHEREAS, in accordance with the project implementation timelines, the appropriated budget for the project could no longer be accessed/utilized;

WHEREAS, pursuant to Section 41 of the 2016 Revised Implementing Rules and Regulations of RA 9184, the Head of the Procuring Entity reserves the right to accept or reject any or all bids, and annul the bidding process at any time prior to the contract award, without thereby incurring any liability to the affected bidder or bidders;

WHEREAS, above premises considered, we, the members of the Bids and Awards Committee (BAC), **BE IT RESOLVED**, as it is hereby **RESOLVED** to **CANCEL** the conduct of procurement for the **Supply of Labor, Materials and Equipment for the Dredging of San Cristobal River Mouth and Access to Cardona Ferry Terminal with Contract No. DREDGING-2021-17** by virtue of his powers granted under the Reservation Clause (Section 41 (c) of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184;

RESOLVED FURTHER, that the bidders may request for refund of the payment for the cost of the bidding documents;
